#### RAP RATES ARE NOW AVAILBLE ON OUR WEBSITE!

The Resettlement Assistance Program (RAP) rate is the amount of financial assistance provided by the Government of Canada to resettled refugees to establish themselves in Canada. This financial assistance is provided to those who come under Government Assisted Refugees (GAR), Joint Assistance Sponsorship (JAS) and Blended Visa Office-Referred (BVOR) programs. #### RAP financial support includes start up allowances and monthly income support.

#### **Start-up allowances**

Information

• A one-time payment intended to cover the initial cost of settling in Canada. Please note that for BVOR and PSR clients, start-up costs are covered by the sponsoring group.

#### **Monthly income support**

- Monthly income support is intended to cover basic needs such as **food**, **incidentals**, **shelter**, **transportation and a communication allowance**.
- Other special allowances may be added based on need.

#### Why is it important for you to know the RAP rate in your province?

According to the new SAH Agreement and IRCC Financial Guide to Sponsorship, the benchmark level of financial support under private sponsorship is equivalent to RAP rates. This means that you as a sponsor should provide income support at least equivalent to the amount of the RAP rate in the community of settlement, in order to fulfil your financial responsibility as a sponsor.

How Sponsors Can Help IRCC Offices in Processing PSR applications	
Family Composition	<ul> <li>All changes to family composition MUST be declared to the IRCC Office prior to travelling to Canada</li> <li>Those who are not declared will be ineligible for the OYW program and sponsorship under the Family Class.</li> </ul>
Communication	<ul> <li>Sponsors must ensure that they have up to date contact information for the refugees they are sponsoring, and that the IRCC Office processing the application is advised when applicants have moved or changed their phone number or email.</li> <li>Sponsors can assist processing by passing on communication to applicants (e.g. interview convocation and request letters) given the difficulty with communications in some locations.</li> </ul>
Eligibility	• Encourage applicants to be forthcoming and truthful with all information provided to the IRCC Office, as not doing so could lead to the refusal of their application.
Interview	<ul> <li>Sponsors should ensure applicants come prepared to the interview with requested documentation listed on the convocation letter</li> </ul>
Personal History	<ul> <li>Applicants must be forthcoming with all relevant information about any membership in groups, including political, and/or any experience with the military, particularly in armed conflict</li> <li>Failure to provide truthful information about personal history may lead to refusal</li> </ul>
Establishing Identity	<ul> <li>Lack of documentation can cause delays in establishing relationships.</li> <li>In cases of identity fraud, applications are refused after taking procedural fairness steps to advise the applicant of the concerns.</li> </ul>
Registration	• If the applicant has resettled to another country, the applicant or sponsor should follow the withdrawal process described in IP3/Part 3/Section 50 (IP3, part 3 - withdrawal).
