

Highlights from Visa Office Specific Information on PSR processing

Common Challenges Faced by Visa Offices and How Sponsors Can Help

Family Composition

- Most delays in processing occur as a result of the addition of dependants being added at the end stages of processing. Sponsors are encouraged to be proactive in submitting required documentation and forms to the Refugee Operations Center in Ottawa (ROC-O) when they first become aware of new dependants.
- De-facto Dependants: Unless a clear relationship of dependency can be established, sponsors should submit separate applications for new, adult applicants who are not the spouse or children of the principal applicant (such as siblings).

Communication

- · Most refusals or withdrawals occur because the visa office cannot contact the applicant to proceed with the application.
- Sponsors must ensure that they have up to date contact information for the refugees they are sponsoring
- Sponsors can assist processing by passing on communication to applicants (e.g. interview convocation and request letters) given the difficulty with communications in some locations.

Eligibility

- An applicant may provide elaborate details on forms, yet when they are interviewed and pressed for further details or questioned on the details presented in the forms, the applicants are often unable to recount what they already provided on paper or they provide vague responses which can be contradictory to the forms.
- In some cases, applicants may only be adding to or embellishing their accounts, which erodes their credibility unnecessarily.
- Encourage applicants to be forthcoming and truthful with all information provided to the visa office, as not doing so could lead to the refusal of their application.

Interviews and Documents:

- Sponsors should ensure applicants come prepared to the interview with requested documentation listed on the convocation letter, such as updated and completed Schedule A for each dependant over the age of 18 and completed forms for each new family member (children, spouse) not listed on the original application.
- Sponsors should advise applicants to only submit genuine documentation with their applications.

Background / Personal History:

- Although information about political or military history may not render the applicant inadmissible, failure to provide truthful information about personal history will lead to refusal.
- To reduce processing time and the need to request additional information, applicants that have worked for the government, or have military history, should also include a detailed Government/Military table. These applications may take longer to process as background checks will be required.

Information

- Sponsors are encouraged to familiarize themselves with the **Country of Origin Information** available on UNHCR's RefWorld.
- Visa officers use this to assess the credibility of claims.



0554-07-17- Eritrean Family of 8

We have a BVOR Eritrean family of 8, including 6 children between 1 and 12 years old. PA and his family have a well-founded fear of return to Eritrea on grounds of imputed political opinion. PA and his family are seeking a better life and would appreciate the assistance of a sponsor during his resettlement in Canada. The family would benefit from additional support to help them integrate into Canadian life, including providing basic knowledge and necessities. They have a relative in Canada, the spouse's mother in Winnipeg (MB), and would like to resettle near them.

0551-07-17- Large Iraqi family and PA speaks some English

Large Iraqi family with older children. The PA was a market owner and his wife has some experience as a Primary school teacher. 0577-07-17- Single Congolese male

The PA is a 20 year old male and he is at risk. He has a grade 11 education and he is able to communicate well in English. The PA is seeking a better life and would appreciate the assistance of a sponsor during his resettlement in Canada.

You Asked...

What forms should a recently arrived refugee use to bring his family under the one year window program?

We Answered...

For refugees sponsored under the PSR and BVOR programs, the following forms need to be completed for a One-Year Window of Opportunity Provisions application:

- Request for Processing Family Members under the One-Year Window of Opportunity Provisions (IMM 5571);
- Generic Application for Canada (IMM 0008) (in the name of the dependent/s coming under the One-Year Window of Opportunity Provisions); and, if applicable,
- Schedule A Background/Declaration (IMM 5669).

The PA who is already in Canada, would also needs to include a copy of his/her Permanent Residence card or Confirmation of Permanent Residence with the application package.
