Changes to Group of Five and Community Sponsorship applications to sponsor Syrian and Iraqi refugees

December 19, 2016: IRCC announced that 1,000 Syrian and Iraqi refugees will be exempt from the refugee documentation requirement. After the first thousand persons, the IRCC will return applications that do not have official refugee status documents. As it is not possible to know in advance whether the limit of the 1,000 persons has been reached, it is advisable for Groups of Five and Community Sponsor organizations sponsoring Syrian and Iraqi refugees to include refugee status recognition documents where available.

INQUIRIES & RESPONSES

You asked....

Could you clarify whether the \$10,000 maximum limit on travel loans applies to a family that is linked, or whether it is applied to each application separately?

Our response...

In general, the IRCC grants the Principal Applicant (PA) and their dependents a transportation and admissibility loans for up to \$10,000 for the whole family. IRCC will cover any remaining debts. Applicants on linked files (e.g. adult children or de facto dependants who are adults) will receive their own separate travel loans.

You asked...

How do we submit our application electronically? Do we have to submit signature sections separately under registered mail?

IRCC response...

You can submit your Sponsorship electronically and find useful information under Latest Policy & Program Updates on the RSTP website <u>HERE</u>. Upon completion of the application Visa Offices will often require a physical Photo in order to attach it to the PR Card. Please note that all forms MUST be typed. In the past, handwritten forms slowed down the intake process significantly as the information was not legible. It is also important to note that due to information technology (IT) restrictions, your overall email (text and attachments) cannot be bigger than 10MB. If you email is bigger than 10MB, it will bounce back and you will NOT receive an email auto-reply from CPO-W. (Courtesy of Debra Simson, SAH secretariat)

Electronic submission of the IMM 0008

RSTP has been receiving questions regarding electronic submission of the Generic Application Form for Canada (IMM 0008) asking for advice to ensure that the barcodes are legible and will be accepted by CPO-W.

Courtesy of Ellen Woolaver from the SAH Secretariat, we would like to share a tip that sponsors might find useful:

Sponsors could submit both the original barcode pages (which are bright and clear) as well as the barcode page with the signature (which would have been forwarded to the applicant, printed, signed, scanned and emailed back - so is not so bright and clear).
