# A LOOK BACK: Resettled Refugees in Ontario in the last Year

- Resettled refugee arrivals more than doubled compared to 2015
- Ontario received over 15,000 Syrian refugees
- 85% of Syrian refugees settled in the GTA, Ottawa, Hamilton, Kitchener, London and Windsor

# BVOR PROFILE #: 0522-06-17- Single Colombian male

The PA is a 39 year old Colombian male. He has 13 years of education and experience repairing cell phones and as a juice seller. The PA fears persecution due to his beliefs. The PA is seeking a better life and would appreciate the assistance of a sponsor during his resettlement in Canada.

#### **BVOR PROFILE #: 0445-05-17-** Eritrean Woman and five school aged children

The PA is a 45 year old Sudanese woman of Eritrean nationality. She is accompanied by her five school-aged children. The PA has no formal education and limited work experience. All but the youngest child have some education and are eager to continue on with their studies. The PA and her family cannot return to their country of origin due to a well-founded fear of persecution based on political opinion. The family would benefit from the assistance of a sponsor upon resettlement to Canada.

# In Canada JAS Profile:

# Single Iraqi Woman with Six Children (In-Canada JAS 0552-07-17)

We have an in Canada JAS Case where the PA is a 30-year-old Iraqi woman with 6 children. The PA's eldest child is currently receiving medical attention for physical trauma they had experienced overseas. The PA only speaks Kurmanji, and it has been difficult finding interpreters. The family experienced a great deal of trauma and would benefit from the support of a Sponsor. A sponsor group could provide an increased level of support and education around basic life skills for living in Canada, financial literacy, a chance to practice English on a daily basis, social and emotional support, accompaniment to medical appointments, and opportunities for the children to connect more actively with other families and children.
