Update from IRCC

Please be advised that effective immediately, the Resettlement Operations Centre in Ottawa (ROC-O) will be accepting outdated versions of the IMM008 *Generic Application Form for Canada*, as long as 2-D barcodes are generated and are legible. By "legible", ROC-O needs to be able to scan them using their barcode scanners so the information can be uploaded into GCMS.



Available VOR Case:

VOR 0387-05-17 (Not travel ready)

Case summary: The PA is a single mother accompanied with her 1 year old daughter. PA's husband disappeared few years ago and she has no contact since then. She fears for her safety and for the life of her child. She can speak English and has 9 years of formal education. The PA and her daughter cannot return to their home country due to ongoing insecurity and they fear persecution based on their ethnicity. The PA will benefit physically, emotionally, and socially to be surround by trusted people to help her with her new life in the host community during her resettlement. She is a woman at risk who is seeking to better her family's life by resettling in Canada. This is a VOR case and no government support is provided. The preferred destination is outside of Ontario.

MONTH 13 AND LESSONS LEARNED FROM EVALUATION OF REFUGEE SPONSORSHIP DONE BY THE RIPPLE REFUGEE PROJECT

The evaluation of sponsorship was done by the The Ripple Refugee Project—a sponsor group based in Toronto—as the groups moved into the 13th month.

The survey was conducted on a one-onone basis between the individual members of the newcomer family and an Arabic speaking volunteer, without any of our sponsorship team members being present. The questions were provided ahead of time, in Arabic, and the family members were encouraged to be as critical as possible.

QUESTIONS & ANSWERS

Question:

Change of composition of a Group of Five. What would be the process of reporting a change of G5 composition – i.e. of one current group member is being replaced by another person? Our understanding is the group would need to complete a new Undertaking, a new Settlement Plan; the new group member would need to complete a Sponsor Assessment form, submit proof of citizenship or PR status in Canada, and, if contributing funds, then the person would need to complete and sign a Financial Profile and provide proof of Income. All of these documents can be submitted to ROC-O by e-mail. Is this correct? What would be the process once this request to change a group member has been received by ROC-O? Would the case be placed on hold? What is the case is already with an overseas visa office? Would this impact processing time?

Answer from ROC-O:

In terms of a change of composition for a G5, yes, you are correct. If a new group member is being replaced by another person, you will need to complete all forms you list above; Undertaking, a new Settlement Plan; the new group member would need to complete a Sponsor Assessment form, submit proof of citizenship or PR status in Canada, and, if contributing funds, then the person would need to complete and sign a Financial Profile and provide proof of Income. Once the complete application is received at ROC-O, it will go into the queue like any new application received at ROC-O. If the appli-

cation is already overseas and if the applicant is close to having a visa issued and the medical exam validity is close to its expiry date, changing the composition of the G5 may impact processing times. If this is the case, we can expedite the application.

Imporant to note:
"Accompanying" vs. "Non-accompanying"
Dependants



As it was explained during the conference, please indicated all family members who intent to come to Canada as "accompanying" even if they are living in different locations. If family members who plan to come with PA are not in the same location as the PA, the visa officer will do every effort, depending on various factors, including as access to these families, to process the application of the whole family unit and resettle them together.

On the other hand, if the where about of family members are not known or family members do not intent to be resettled with the principal applicant at the time of submission, please indicate "non-accompanying". In those circumstances, the visa office will only process the application of the principal applicant. Note that the SAH Council already shared the same information to all Association members.
