Correction Regarding Travel Loan Waiver:

Previously we have stated that, "The cost for transportation and the medical examination overseas will be covered by IRCC for any Syrian PSR (or GAR/BVOR) arriving after November 4 as part of the Government's commitment to resettle 25,000 Syrian refugees by February 2016." However, we got clarification from IRCC stating that the loan waiver cut-off date was December 31, 2016; therefore all Syrian refugees who landed after January 1st, 2017 did not have their loans waived even if they were interviewed between November 4th and December 29th, 2016.

REFUGEES FOR RESETTLEMENT

In 2016, UNHCR referred 162,600 refugees to States for resettlement. According to government statistics, 37 countries admitted 189,300 refugees for resettlement during the year, including those resettled with UNHCR's assistance. The United States of America admitted the highest number (96,900).

Unaccompanied or separated children – mainly Afghans, and Syrians – lodged some 75,000 asylum applications in 70 countries during the year, although this figure is assumed to be an underestimate. Germany received the highest number of these applications (35,900).

MILLION NEW CLAIMS

The number of new asylum claims remained high at 2.0 million. With 722,400 such claims, Germany was the world's largest recipient of new individual applications, followed by the United States of America (262,000), Italy (123,000), and Turkey (78,600).

Lebanon continued to host the largest number of refugees relative to its national population, where 1 in 6 people was a refugee. Jordan (1 in 11) and Turkey (1 in 28) ranked second and third, respectively.

This group grew by
64 per cent during the second half of 2016 from 854,100 to over 1.4 million, the majority of whom were children.

INQUIRIES & RESPONSES...

YOU ASKED...

Regarding Acknowledgement of Receipt

"I submitted an application for a group of five sponsorship in the mail on April 19th and have not received a confirmation that the application has been received. Do you have any advice for this? The website said there should be a confirmation within 30 days, which has passed already."

OUR RESPONSE...

Please note that ROC-O is currently not issuing acknowledgements of receipt for applications submitted via mail, which is why we recommend sponsors use tracked mail when submitting applications. If there is



a mistake or error with the application, ROC-O will return the application within three to four weeks. If there are no mistakes or errors, then the file will enter into a queue and the first communication you will receive will be the "G" file number via email, which can take some time to be assigned.

Anyone who did not receive an auto reply to their application submitted via email, should send a follow-up e-mail to ROC-O letting them know that an application has been sent but no automatic reply received and ROC-O will let them know if their application has been received or not. If not, then sponsors would need to re-submit the application.

If a sponsor has submitted multiple applications at the same time and has not received an automated message for all the e-mails submitted (e.g. sponsor submitted 3 applications in 3 separate e-mails and only received two AOR messages), then it would be recommended for the sponsor to send a follow-up e-mail to ROC-O advising them that 3 applications had been submitted (and providing details of the PAs) but only 2 AORs were received. And then ROC-O will advise if they have received all three applications or if one of them did not go through.

- There are some higher needs cases and some larger families as well.
- Woman at risk.

One of the available BVOR profiles is an Iraqi Family of 6:

Young couple with 4 small children ranging from 2 to 9 years old. The PA was co-owner of an Internet Café and supermarket with his brother before fleeing his home country. The PA has a cousin residing in Ottawa and a Brother in Quebec. He would prefer to live in the Ottawa area to be close to family.
