INQUIRIES & RESPONSES...

YOU ASKED...

- 1. Does the application submitted under One Year Window of Opportunity (OWY) receive a <u>unique G number</u> or will it be processed under the G number that was initially assigned to the PA who is now residing in Canada as a permanent resident?
- 2. Can we check the status of the case associated with this number online?

OUR RESPONSE...

- **1.** The OYW applicant will get their own <u>G number</u> and <u>UCI number</u> different from the G number/ UCI the PR family member already in Canada has.
- **2.** Yes, it is possible to track a OYW application with a G number. However, it typically takes around a year after submission before actual updates are available online.

While the OYW application is still in Canada, the application is still under the PA in Canada's UCI and G number. Once the OYW application is received by the Canadian visa office overseas the OYW dependent will be contacted (the trend seems to be predominately by email, but a physical letter in the mail is also possible), where they are then issued their unique UCI and G number.

At this point, using this new UCI/G

number, to check status updates should be possible (although not always). Typical messages are "correspondence submitted to you on X date" (which means that an email/letter has been sent to the applicants with notice of an interview date/medical appointment etc).


YOU ASKED...

Is it okay to submit the sponsorship with an expired Refugee Certificate card?

OUR RESPONSE...

The refugee status document has to be valid when the sponsorship application is submitted by a Group of Five.

In practice, we have seen applications returned to Groups of Five who have submitted applications with expired refugee

Pregnant Congolese Single Woman with a Young Son

PROFILE #: 0154-04-17:

The PA is a Congolese women, who is single and in her last stage of pregnancy due at the end of May. She also has a young son. She can speak English and has experience working as Nutrition Assistant. The PA doesn't have any relatives in Canada, so she needs support to help her in her daily life and through her transition to new life in Canada. She also needs emotional support to help her deal with her traumatic past. The PA will benefit from the assistance of a sponsor during her resettlement. She will benefit physically, emotionally, and socially to be surround by trusted people to help her with her new life in the host community. She needs help with finding assistance for her son, as she prepares to give birth very soon. The family is currently residing in London, Ontario and they would appreciate the assistance of a sponsor in London or surrounding areas.
