IRCC has recently published a notice on upcoming changes to the age of dependent from 19 to 22 years old. The notice calls the public to provide written comments. Knowledge of official language: GAR 26%, PSR 38%, BVOR refugees 14%.

Education level - nine or fewer years of education : GAR 61%, PSR 48%, BVOR refugees 54%.

Country of citizenship (top three): GAR (Iraq, Bhutan, Somalia); PSRs (Iraq, Eritrea, Ethiopia) and BVOR refugees (Myanmar, Eritrea, Iran)

GAR 47%, PSR 57%, BVOR refugees 56%).
