

#### **Changes within IRCC**

Effective September 12, 2016, responsibility for the delivery of immigration and citizenship programs in Canada was moved under a single Director General located at NHQ. Responsibility for the delivery of integration programs (Settlement as well as the Resettlement Assistance Program - RAP) in Canada was moved under a Director General of the newly named **Settlement Network (SN)** at NHQ in Ottawa.

#### Citizenship Week

Citizenship Week will be celebrated across Canada from **October 10 to 16, 2016.** IRCC is encouraging Canadians, including former sponsored refugees, to share their thoughts on what it means to be Canadian, stories of citizenship journey, or photos or videos of citizenship ceremony through Facebook, Twitter and Instagram using the hashtag #MyCitizenship.

#### **INQUIRIES & RESPONSES**

**You asked...** A BVOR couple arrived in June. The wife, the PA was sent a letter requesting a new photo and later sent a card but the husband was not asked for a new photo and no card has come either. The wife's card arrived more than a month ago. I've waited in case the husband's PR card was just late but I don't think this is the case. Do you have a suggestion about how he can inquire about his PR card?

Once you do that, you can follow-up with the PR Card Processing Centre. Although we do not have a direct phone number for this office, you can contact them through <a href="IRCC Web form">IRCC Web form</a> or Telephone number: 1-888-242-2100. A settlement counsellor from our office suggests calling early in the morning. Also, you may need to call while the client is with you; otherwise, the Call Centre staff may refuse to discuss the matter with you due to privacy reasons. Having the client will allow the Centre to confirm that you are authorized to talk and receive information on the behalf of the client.

**You asked...** We've been approached by someone who is a convention refugee but not yet a permanent resident who wants to sponsor his sister and her family. He is willing to deposit money and work with a church to his sponsor his relatives. We are wondering whether he can co-sign the Undertaking as a co-sponsor without being a PR or a citizen. Can you please advise?

**Our response** ... That will not be possible. If he signs the undertaking, he will have to complete the sponsor assessment form that requires one to be a permanent resident or a citizen. Having said that, the church can enter into a side agreement with him and sponsor his relatives. He can still be included in the settlement plan and requested to deposit money. But, this means he cannot be held liable by IRCC in case sponsorship breakdown or default, as he is not a formal signatory of the sponsorship undertaking. However, the church can hold him responsible on the basis of an agreement or MOU signed between the two parties.

There are three options for your group, you can

- 1- Sign a MOU with him, require him to deposit money and proceed with the sponsorship. When he becomes a PR during the process of the application, update the undertaking and settlement plan. At that stage, you can submit the updated undertaking to CPOW (with an explanation that this is not a new sponsorship) if the church needs him to be on a record as a cosponsor.
- 2. Request him to get another co-sponsor who can sign a sponsorship undertaking while he still deposit money and participates in the settlement of refugees.
- 3. Wait until he becomes a PR.
