2016 IRCC Immigration Consultations: Until August 5, 2016

From July 5th, 2016 until August 5th, 2016, the Government of Canada is engaging Canadians with questions about immigration to inform their current immigration planning. Click here for further information.

All Canadians, including you, members of your organization, your CGs and Co-sponsors, can get involved by providing an on-line written submission. Other consultation activities include cross-Canada round-table discussions led by the Minister and Parliamentary Secretary, stakeholder engagement by departmental officials; and, public opinion research.

While there is representation of SAHs by the SAH Council with IRCC, the immigration consultations serve as another opportunity to raise your voice and share your opinion as a stakeholder.

Dental Care for Refugees:

Interim Federal Health Program

Since there were changes to the Interim Federal Health (IFH) Program that came into effect on April 1st, 2016, many of you have asked us for information regarding the dental coverage provided under IFH. Under IFH, emergency dental care involving pain, infection or trauma is covered for the first year. Medavie Blue Cross notes that IFH is "not intended to provide on-going regular or routine dental care." Dentists need to be registered with Medavie Blue Cross in order to be reimbursed. Click here for further information from Medavie Blue Cross and a dental benefit grid detailing dental treatments and whether pre-authorization is required.

Medavie Blue Cross lists the following dental services that are covered under the **Interim Federal Health:**

- Emergency Examinations: Emergency examinations are covered no more than once every six months per dental office.
- Diagnostic Radiography: X-rays are covered with restrictions on number and type.
- Restorations: Restorations are covered for severely affected teeth only. All restorations must be pre-approved by submitting X-rays.
- Extractions: Uncomplicated emergency extractions do not require preapproval. All complicated extraction codes must be submitted with X-rays for justification.
- Emergency Prescriptions: Only those needed to treat the emergency conditions there are charges for prescribing emergency medications.

 Anesthetics: Anaesthetics are covered with restrictions dependent on the age of the
- patient. All anesthetics must be submitted for predetermination.

Medavie Blue Cross states that the following dental services are not covered under IFH:

- Routine root canal treatments, orthodontics, temporary and permanent prosthetics:
- Intravenous sedation and nitrous oxide:
- Prophylaxis and fluoride;
- Facility fees;
- Specialist fees (unless specially approved for oral surgeons and pedodontists);
- Pulpotomies and stainless steel crowns;
- Bite-wing X-rays;
- Restoration of incipient lesions or those not visible on an X-ray as it is considered routine care:
- Scaling and root planing complete or partial dentures and relines.

After contacting the dentist, you will need to ask if they accept patients who have insurance coverage under Interim Federal Health Program.
