# When a Co-Sponsor Relocates

As a reminder, IRCC (the responsible visa office) should be advised if one of your co-sponsors relocates and the community of destination changes as a result. IRCC has seen a number of cases where the refugee had to be re-destined after the NAT had been provided when they learned that the co-sponsor had moved since the sponsorship undertaking was initially approved. As a SAH, you must also make sure that residency requirements continue to be met if the co-sponsor relocates. The SAH or CG/co-sponsor (whoever is providing settlement support) must reside in the community of settlement in order to fulfill their commitment as a sponsoring group.

# Government of Lebanon No Readmission Policy

UNHCR has verified that the Government of Lebanon has a <u>no readmission</u> policy. This means that all cases that have left Lebanon for resettlement in Canada would have been given <u>a re-entry ban</u> upon departure from Lebanon.

# Issuing of IFHP at the Port of Entry

We have received confirmation from IRCC that effective April 11, 2016, IFHP coverage for all resettled refugees is **issued by the CBSA at the Port of Entry upon arrival.** 

In some cases where the IFH Certificate cannot be printed at a Port of Entry, IFHP coverage should be issued by an IRCC officer shortly after arrival.

#### **Outdated Forms and Grace Periods**

While we shared this information over the SAH list on May 26th, we want to share in the RSTP Bulletin also IRCC's message about outdated versions of forms and the grace period in which outdated versions will still be accepted and processed. Note that this information refers to ALL forms and applies only to SAHs.

"This is to inform you that the grace period for acceptance of outdated versions of forms submitted by SAHs to CPO-W has been extended to July 31st, 2016. During this grace period, CPO-W will continue to accept and process outdated forms, but will advise SAHs submitting these older versions that new versions are available and should be used in subsequent submissions. Older form versions submitted after July 31st, 2016 will be returned unprocessed. In cases where information required for processing is missing from the older form version submitted, CPO-W will contact the SAH by email. Prompt responses to these enquiries will help avoid delays in processing.

A 6-month grace period will apply to all future forms updates unless otherwise stated."
