## Why File Income Tax

It is important that everyone, including resettled refugees, file taxes to report all income earned, both inside and outside Canada, for the part of the year they were a resident of Canada. Even if the resettled family does not have income in the year, the information provided will be used to calculate federal benefits, credits and any related provincial and territorial programs that the individual or family may be eligible for

## **Monthly Income Support**

The financial support provided through the government funded Resettlement Assistance Program (RAP) and the monthly income support provided by the sponsors are generally considered gifts. These monthly amounts are given voluntarily and are not exchanged for any service, property, or obligation, therefore they are not taxable.

## Filing a Tax Return

Different forms are used in different provinces and territories. Use the form for the province or territory the newcomers live in. File online or complete the form and mail it to Canada Revenue Agency (CRA):

- Visit **cra.gc.ca/GetReady** for all the information you need to help you file online OR
- Send your completed form by mail addresses can be found at cra.gc.ca/taxcentre

#### **Documents Needed**

- Social Insurance Number (SIN)
- <u>Tax information slips</u> such as <u>T4</u> slips that show the individual's income
- Income Statements from Canada and abroad

## **Support for Filing Income Tax**

### **Community Volunteer Income Tax Program**

• A free program where community organizations host volunteers to prepare income tax and benefit returns for those with a modest income and a simple tax situation.

#### **Deadline**

• Most income tax and benefit returns are due on or before April 30, 2018.

The PA is a 38-year-old Afghani single mother with four school-aged children. She has work experience in handicrafts, tailoring and hairdressing. The family has been persecuted in their home country due to political opinion.

### ADDITIONAL INFORMATION: No preferred destination

The PA is a 32-year-old Eritrean male with 11 years of education. He speaks English and has experience working in a mechanic's shop. His wife has 10 years of education. Their daughter is school-aged and is in need of constant care. This family has been persecuted in their home country based on political opinion.

**BVOR PROFILE #: 0961-02-18** 

ADDITIONAL INFORMATION: Cousin in Mississauga, ON

Syrian family size seven. The PA and his spouse have five school-age children. The spouse has some medical issues and has experienced trauma but her conditions are well-managed and stable. The youngest son has infantile autism and has not received adequate treatment due to the family's flight from their country of origin. The family has demonstrated resilience in the face of trauma and violence.

The PA is a 42-year-old Congolese married man with five children. He has farming experience and speaks some French. The PA has a relative on the x-ref file BVOR 0939-02-18 and they should resettle together.

### ADDITIONAL INFORMATION: Preferred destination Winnipeg, MB near relatives

Pakistani family of six with four children. The PA and spouse both have a good educational background and can speak English. The four children also speak English and are students. The PA has experience working as an engineer and interpreter, and his spouse as a teacher. The spouse has distant relatives in Winnipeg, MB and would like to be resettled near them. They cannot return to their home country as they fear for their safety.
