## **Use of Old Generic Forms (IMM 0008)**

#### You Asked

Why has IRCC changed the **Generic Application Form for Canada** (**IMM 0008**) and will ROC-O accept the old forms?

#### **We Answer**

The IMM form is used by IRCC for several immigration streams, the changes in the new form may not necessarily be applicable to refugee sponsorship applications, but may be more important in other immigration programs.

ROC-O will continue accepting older versions of the form, provided they have been validated and have the 2-D barcode printed on them.

### **Cost of Second Medical Examination**

#### You Asked

The refugee family we are sponsoring has to re-do their medical examination. Who pays for it?

#### **IRCC's Response**

We contacted IRCC and below is their response:

The Immigration Medical Examination (IME) completed <u>overseas</u> is now covered by the Interim Federal Health Program (IFHP) under the Pre-Departure Medical Services (PDMS).

There is no limit of the number of IMEs a GAR/PSR beneficiary can have overseas. So if the IME has expired before a GAR/PSR\* arrives in Canada, it can be redone and will be covered by PDMS. The only limitation is the frequency one IME per eight calendar months as per the **PDMS benefit grid**

**Family composition:** The PA and her spouse have 4 young children. **(Country of Origin:** 

Sudan)

**Background:** The family landed in Calgary in November 2016 after escaping their home country, Sudan. The family has faced trauma and violence prior to coming to Canada and are facing a number of challenges to their successful settlement in Canada.

The PA's husband is a survivor of violence, and has lost mobility in his hands. He has undergone one surgery since arriving in Canada and is due for a number of others in the coming months.



The family has received some life skills training but would benefit from further support while continuing to grow their confidence and become more independent.

Family composition: The PA and his spouse. (Country of Origin: Syria)

**Background:** The PA and his spouse arrived in Calgary in November 2016 and have faced a number of issues since arrival. **Background:** The PA has limited education and work experience as well as limited English skills. The three oldest children are in school and have learned Basic English but the PA has not yet been able to attend English language classes as she is the only caregiver for her younger children.

Since settling in Canada, the PA has received support in learning life skills and her confidence is growing. She is able to conduct her own grocery shopping and bill-paying but requires additional support as well as language and skills training to become more independent.

**Support Needed:** In addition to the day-to-day needs of her children, she has been attending to the on-going medical needs of the baby and her own trauma and psychological needs.

The PA is a survivor of trauma and violence and requires counselling as well as emotional support in order to provide stability for her children and develop her life in Canada. The JAS program and the support of a sponsor will provide some of the needed social and emotional comfort and support that are needed for the PA to become self-sufficient
