

## **BVOR Updates**

- Currently, we have not received any new BVOR profiles, we are not exactly sure as to when we will be receiving the new profiles. IRCC may continue to deal with the replacement cases before we receive new profiles. Once we receive more information regarding the date for the BVOR Profiles, we will certainly let you know.
- Note about replacement cases: why replacement? The cases
  in question were posted before they were travel-ready in order to expedite the process. When these cases were first
  offered, sponsors were advised that they were still pending
  security and medical screenings and that delays could occur.
- Replacement cases are offered for those cases that are still
  pending because of admissibility checks, who have been refused or who have chosen to withdraw their application for
  resettlement to Canada.
- It is important to note that the Matching Centre is only offering replacement cases to SAHs and the corresponding CGs that did not receive their cases. The replacement is only for that CG, and the SAH is not able to offer it to another group.
