## **SETTLEMENT**

In Yukon, settlement services are offered at the <u>Multicultural Centre of the Yukon</u> (MCY) and <u>L'Association franco-yukonnaise</u> (AFY).

Applications submitted after <u>June 01, 2018</u>, that do not use the new forms or adhere to the new requirements will be returned or refused.

## **Highlights from updated Guide of the PSR Program**

Updates on Documents that G5 sponsors need to submit:

## **Criminal Record Check**

- Each sponsor must submit a copy of a criminal record check (non-vulnerable sector check) issued within 6 months prior to the submission of their application to ROC-O.
- If there is a criminal conviction, applicable police and court documents showing the disposition of charges.

## Updates on Documents that CS need to submit:

#### **Criminal Record Check**

- The CS Signing Authority and/or the individual co-sponsor and/or the organizational co-sponsor Signing Authority must submit a copy of a criminal record check (non-vulnerable sector check) issued within 6 months of their application submission to ROC-O.
- If any of the above sponsors has previous criminal convictions, submit copies of applicable court documents which show the disposition of the charges.
