

You Asked

How do we check that an individual was approved as a refugee by the UNHCR in Turkey?

We Answered

UNHCR Turkey has a website where applicants, using their file number and date of birth, can check the status of their application:

http://results.unhcr.org.tr/default.aspx

The individual in Turkey should be able to log into the above website for updates on the status of their refugee claim.



You Asked

A number of SAHs have asked for clarification on whether the photos for the refugee applicants now need to be taken by a professional photographer to comply with the PR photo specifications (as stated in the new Instruction Guide), or can non-professional photos be used, as was previously communicated to SAHs.

We Answered

IRCC confirmed with ROC-O that the refugee applicant photos need to be taken by a commercial photographer per the instructions provided in the updated IMM 600 guide. This is the standard across the Department.

Photos

Provide one (1) photo of the PA and each of the PA's family members taken in the last six (6) months. The name and date of birth of the person must be printed clearly on each photo. Follow the instructions provided on the **Permanent resident photograph specifications**

Photos must be:

- Taken by a commercial photographer.
- 50 mm wide X 70 mm high (2 inches wide x 2- 3/4 inches long) and sized so the height of the face measures between 31 mm (1- 1/4 inches) and 36 mm (1- 7/16 inches) from chin to crown of head (natural top of head).
- Clear, sharp and in focus.
- Taken with a neutral facial expression (eyes open and clearly visible, mouth closed, no smiling).
- Taken with uniform lighting and **not show** shadows, glare or flash reflections.
- Taken straight on, with face and shoulders **centered** and squared to the camera (i.e. the photographs must show the full front view of the person's head and shoulders, showing full face centered in the middle of the photograph).
- Taken in front of a plain white background with a clear difference between your face and the background. Photos must reflect/represent natural skin tones.
- Original photos that are **not altered in any way** or taken from an existing photo.

The back of one photo must include:

- the subject's name and date of birth
- the name and complete address of the photography studio
- the date the photograph was taken



The photographer may use a stamp or handwrite this information. Stick-on labels are unacceptable.
