Clarifications on Post-Arrival Requirements for Secondary Migration

In situations where refugees move after arrival in Canada (secondary migration), the sponsors are expected to try to meet the residency requirements.

In most cases, this involves appointing representatives using the <u>IMM 5956</u> form. The sponsors should work as quickly as possible to resolve these situations. It is in the newcomers' best interests to ensure that they have adequate support. When possible, alternate sponsorship arrangements should be made as per the guidance on residency requirements found at the following link:

The sponsors are responsible for contacting IRCC as soon as they become aware of the sponsored refugees re-destining post-arrival. The sponsors can contact IRCC through the PSR case review email

<u>IRCC.PSRCaseReview-RevuedecasPSR.IRCC@cic.gc.ca</u>. It is in the best interests of the sponsors to resolve these situations as they are liable for all support until IRCC deems otherwise. If the sponsors are unable to find alternate sponsorship arrangements, they can explain in detail the steps they took meet these requirements. If the PSR Case Review Team is satisfied that a reasonable effort was made, this will be taken into consideration and likely not result in a finding of sponsorship breakdown.

You Asked

What happens if a sponsoring group is not willing to add a spouse or a common law partner to an existing application being processed by IRCC?

Our Answer

Inland Processing IP-3 Part 3: Private Sponsorship of Refugees Program (pp.55-56) states:

"If the sponsoring group is not able to demonstrate its willingness or ability to provide support to the additional family member, the principal refugee's application will likely be refused overseas, so as not to split up the family."

IP-3 further states that if the file is still being processed in Canada, then they will inform the sponsor and the Visa Office that "...there is no viable sponsorship in place." The Visa Office will then "...send the applicant a procedural fairness letter indicating that the applicant has 90 days to secure another sponsorship, or the case will be refused under paragraph R139(1)(f)..."

Joint Assistance Sponsorship (JAS)

Refugees sponsored under the JAS program have special or enhanced needs that will likely result in a longer or more difficult period of integration in Canada due to:

- Trauma from violence or torture;
- Medical disabilities;
- Effects of systemic discrimination; or,
- Large family units (such as a single parent with several children).

Family composition: This Iraqi woman came to Canada with her oldest brother, her sister-in-law and four siblings.

Medical and other needs: She suffers from trauma as a survivor of Daesh. Appropriate referrals for her and other family members have been made. The woman's oldest brother and his wife are caring for her and her siblings. This new guardianship situation has proved difficult for the whole family.

Support needed: The woman and her family would benefit from continuous support to help to recover from emotional and psychological trauma, to overcome the language barrier and to achieve smooth integration into life in Canada. They are looking forward to attending English classes so they can be more independent and self-confident in their daily tasks.

Support needed: Given their experience with violence and trauma, a sponsor would help provide the family with access to resources and support. In addition, expanding the family's social network would lead to an improved and more successful integration during their settlement in Canada.

Family situation: This 19 year old single male recently arrived in Canada with his family members.

Medical needs: He is a survivor of violence and torture by Daesh, and suffers psychological trauma. He would benefit from counselling, and has indicated an interest in talking to someone.

Support needed: Social and informal emotional support would be valuable. This includes supporting him in addressing a variety of resettlement barriers, practicing English and managing daily life activities, such as commuting around the city and learning how to use a computer.

New Fund Covers Costs of sponsoring up to 1,000 refugees identified by the United Nations Refugee Agency (UNHCR)!

The University of Ottawa Refugee Hub and the Shapiro Foundation, together with Jewish Family Services Ottawa, have announced the creation of a new fund to facilitate the sponsorship of up to 1,000 refugees identified by the UNHCR.

For a limited time, qualifying Canadian groups will have the cost of sponsoring a refugee through the Blended Visa Office Referred (BVOR) program fully covered by the fund. Funding for both start-up costs and settlement costs associated with BVOR sponsorship will be available to groups that submit applications to the fund before September 17, 2018, or until the fund is exhausted prior to the deadline. Refugees sponsored with the support of this fund will arrive in Canada before December 31, 2018.
