

DECLARATION OF FUNDS AND ASSETS ON ARRIVAL OF PRIVATELY SPONSORED REFUGEES

This form is to be used for the purpose of declaring financial assets to a sponsoring group in order to determine income support needs.

Refugees receiving financial support are expected to provide information about their funds and assets as this may impact the level of financial support that is to be provided. **However, the declaration of funds and assets is voluntary and financial support will not be withheld or stopped as a result of non-reporting.**

The Personal Asset Exemption Limits chart outlines the maximum personal assets that refugees can retain without affecting the amount of financial support they may receive. Any remaining assets may be factored in when determining the level of financial support needed. If a refugee declares that they have more than the personal asset exemption limits below, the sponsoring group should provide the option to apply these funds against the balance of the Immigration Loan before deducting any financial support.

If the refugee still has more than the personal asset limit, the sponsoring group can calculate support on a case by case basis taking into account the concepts of self-sufficiency and factoring in only the portion of assets above the exemption limit.

Personal Asset Exemption Limits:

<i>Family composition</i>	Maximum amount allotted of personal assets (Canadian dollars)
<i>Single person</i>	\$5,000
<i>Couple</i>	\$7,500
<i>Single plus one dependant</i>	\$7,500
<i>Each additional dependant</i>	\$2,500

One form per family (case) is required, and should include the total assets of all family members included in the case.
