# IN CASE YOU MISSED IT

## Residency requirements have been updated!

To meet the residency requirements of sponsorship, all the members of the sponsoring group must reside in the refugee's expected community of settlement. If a member of the sponsoring group does not live in the community of settlement, then the sponsoring group can appoint representatives.

#### A representative is:

- A Canadian Citizen or Permanent Resident who is located within the refugee's community;
- Appointed to represent the sponsor in the community;
- Not a party to the sponsorship, and is not liable to fulfill the sponsorship obligations.

The requirements for appointing a representative in the community of settlement vary based on the Sponsorship Category:

For Sponsorship Agreement Holders (SAHs):

- Either the SAH and/or Constituent Group (CG) is located in the community of settlement; **or**
- At least two co-sponsors reside in the community of residence; **or**
- At least two appointed representatives reside in the community of residence.

#### For a Community Sponsors (CS):

- Either the CS is located in the community of settlement; or
- At least two co-sponsors reside in the community of residence; **or**
- At least two appointed representatives reside in the community of residence.

#### For Groups of Five (G5s):

- All five sponsors must reside in the community of settlement; **or**
- Their appointed representatives (for each group member that does not reside in the community of settlement) reside in the community of settlement.

# reminder

Regarding the <u>2-year pilot project for</u> sponsoring <u>undeclared</u> family members (Starting September 09, 2019):

- The public policy will allow someone who arrived in Canada as a resettled refugee to submit a family class sponsorship application for a spouse, partner or child that they did not initially declare on the refugee sponsorship application.
  - ⇒ The undeclared family members will be sponsored under family class and not the OYW.
- As the undeclared family members will be sponsored under the family class, and as the family members were not declared on the original refugee sponsorship undertaking, sponsors are not responsible for providing financial and/or settlement support to the undeclared family members on arrival.
  - ⇒ The resettled refugee in Canada will be responsible for their undeclared family members on arrival.

Further information about how resettled refugees can sponsor undeclared family members through the family class under the pilot project will be released soon.

## The main changes

The residency requirements were updated in June 2019 and under the new requirements, representatives appointed in the new community of settlement <u>must submit a copy of an identification document</u> with the <u>IMM 5956</u> form.

Ideally, the document would include their <u>name and current address</u> (e.g. a copy of a driver's license). If the document does not include the representative's current address, they must also attach a copy of a document with that address (e.g. lease agreement).

# Joint Assistance Sponsorship (JAS)

Refugees sponsored under the **Joint Assistance Sponsorship (JAS)** program have special or enhanced needs that will likely result in a longer or more difficult period of integration in Canada due to:

- Trauma from violence or torture;
- Medical disabilities;
- The effects of systemic discrimination; or,
- Being a large family unit (such as a single parent with several children).

Under the JAS program, the government and private sponsors support refugees for up to 24 months, depending on the needs of the resettled refugee. In a few cases, the private sponsor may support refugees for up to 36 months. These refugees receive income support from the Government of Canada. They are matched with a private sponsorship group to help them adjust to life in Canada with settlement help and emotional support.

Some refugees are identified overseas for the JAS program due to their special needs. Others are converted into JAS cases after they arrive in Canada if it becomes clear that they need more support.

**COUNTRY OF ORIGIN: Iraq** 

**FAMILY SIZE: Two** 

**Background**: A 28-year-old Iraqi woman and her 11-year-old sister arrived in January 2018. She is connected to community resources, volunteers, and language classes but requires additional support. She has a family doctor and has received counselling from a mental health counsellor. English classes are a struggle. She is trying to adjust to her new life in Canada while raising her sister by herself. The sister is registered in school.

**Support Needed:** She would like a sponsor's informal social and emotional support. A sponsoring group could help her learn more about school and employment and practice English. They could help her learn skills such as scheduling appointments; using a computer; managing emails; and getting involved in her community.

ADDITIONAL INFORMATION: Winnipeg, MB

**COUNTRY OF ORIGIN: Syria** 

**FAMILY SIZE: Nine** 

**Background**: This 41-year-old Syrian father arrived with his homemaker wife and their seven children. He has six years of education and has worked as a plumber and pipe fitter. He is fluent in Arabic and has attended some English language classes. The family has received settlement support, but require extra support. Six of the couple's children are registered for school; one is fully dependent on his parents.

**Medical issues:** The family is challenged by the high medical needs of their 4-year-old son. The father has postponed further English lessons as a result and the child's ongoing medical needs have prevented the family from accessing other settlement services and community resources.

**Support Needed:** A sponsor could help with informal English practice and with managing the child's ongoing medical appointments. They could help the family with their daily challenges; and allow them time to develop their English language skills and to integrate in their local community. They will benefit greatly from the physical, emotional, and social support provided by a sponsor.
