#### You Asked

The refugee we have sponosred escaped his country with a false passport. He was blacklisted there and needed to leave with a fake identification (all documented). He also has his expired passport with his real name. When filling out his <u>Generic Application Form for Canada [IMM 0008]</u>, do we use his real name or the assumed name he has been using since leaving?

#### **Our Answer**

As per the <u>instruction guide</u>, the person should put his first and last name as shown on his passport, travel or identity document. In question two of the IMM 0008, the person will have a space to fill out any other names other than the ones he listed in question one. He can put the assumed name here.

In Part A: Case Narrative of <u>Schedule 2</u>: <u>Refugees Outside Canada [IMM 0008/Schedule 2]</u>, the individual gives a detailed explanation of the circumstances under which the fake travel document was obtained to travel to safety. You should add a cover letter giving as much detail as possible with copies of all the supporting documents.

## **You Asked**

We noticed that the name of the person we sponsored is spelled incorrectly on the permanent residence card. How can we correct this error?

## **Our Answer**

If the error is made by IRCC, the newcomer can request a change as indicated in the <u>Change of name due to clerical/ administrative error</u>.

Records such as the record of landing, IMM 1000 or Confirmation of Permanent Residence document will not be amended unless a clerical or administrative error was made by IRCC.

You can submit the official Request to Amend the Record of Landing, Confirmation of Permanent Residence or Valid Temporary Resident Documents. If it is determined that IRCC made a clerical/administrative error, then the name on record will be amended to match the name printed on the primary document. The correct name will be recorded as the primary name and the incorrect

## UPDATES ON THE 2-YEAR PILOT PROJECT

For Sponsoring Undeclared Family Members (Starting September 09, 2019)

We received the following information from IRCC regarding this pilot project:

- The public policy will allow someone who arrived in Canada as a resettled refugee to submit a family class sponsorship application for a spouse, partner or child that they did not initially declare on the refugee sponsorship application.
  - ⇒ The undeclared family members will be sponsored via the family class and not the OYW.
- As the undeclared family members will be sponsored under the family class, and the family members were not declared on the original refugee sponsorship undertaking, sponsors are not responsible for providing financial and/or settlement support to the undeclared family members on arrival.
  - ⇒ The resettled refugee in Canada will be responsible for their undeclared family members on arrival.

Further information about how resettled refugees can sponsor undeclared family members via the family class under the pilot project will be released soon. name will be marked as "entered in error" in IRCC's system of record.

#### Change of name for reasons other than clerical/administrative error

If the mistake you found on the permanent residence card is not a clerical or admistrative error or the person you have sponsored wants to change their original name, then you can do so by completing the appropriate Legal Change of Name Application in your province and paying the respective fees.

Refugees sponsored under the **Joint Assistance Sponsorship (JAS)** program have special or enhanced needs that will likely result in a longer or more difficult period of integration in Canada due to:

- Trauma from violence or torture:
- Medical disabilities;
- The effects of systemic discrimination; or,
- Being a large family unit (such as a single parent with several children).

Under the JAS program, the government and private sponsors support refugees for up to 24 months, depending on the needs of the resettled refugee. In a few cases, the private sponsor may support refugees for up to 36 months. These refugees receive income support from the Government of Canada. They are matched with a private sponsorship group to help them adjust to life in Canada with settlement help and emotional support.

Some refugees are identified overseas for the JAS program due to their special needs. Others are converted into JAS cases after they arrive in Canada if it becomes clear that they need more support.

She has experienced protection issues because of her father's sexual orientation and gender identity. She is fighting for her life as other refugees attempt to poison her because of her father's identity. She is also discriminated against due to her own gender identity.

**Support Needed:** A sponsor could provide extra time and support in order to help her successfully resettle upon arrival.
