The latest news and updates on the Private Sponsorship of Refugees (PSR) Program



### You Asked

A family of five is being sponsored. The mother is the PA, she has a son over 30 years old, one daughter under 22 and 2 other daughters above 22. Four applications will be submitted: one for the PA and her daughter under 22, one for the son, and 1 application/daughter above 22. All applications will be linked.

Can the sponsors use the same in-kind donations for all of them? If separate application packages have to be submitted, can the settlement plans for the linked applications be adjusted based on the PA's settlement plan or does everything have to be separate?

### **Our Answer**

All the principal applicants (of the 4 separate linked PSR applications) have to meet the eligibility and admissibility requirements in their own right; need their own refugee status documents when being sponsored by a Group of Five and Community Sponsor; and, are counted as a family size of 1 when it comes to the finances (the mother and the daughter will be counted as 2 for family size).

The sponsoring groups must meet the settlement and financial capacity for each sponsorship. When the sponsoring group provides in-kind support to each applicant, they can make deductions based on the In-kind Deduction table on the Sponsorship Cost Table for Group of Fives and Community Sponsors and for SAHs based on the Financial Guideline for SAHs. For example, if the shelter was provided fully in kind for the entire family, then the sponsoring group can deduct this amount from all the applications. It is important that each application reflects the financial support and has a clear outline of the group's settlement plan.

### Post Arrival Support

Once the family arrives in Canada and if the children who are above the age of majority reside with their mother, some discretion may be applied to shared costs, which may be reduced provided that overall needs of all family members are met in accordance with <u>RAP guidelines</u>.

Certain household items can be reduced in the start-up costs as well as deductions to monthly income support. In the monthly cost, the shelter amount, which is based on need, can be provided



### **You Asked**

What benchmark are children's ages taken into consideration as dependents in a OYW – at the time that the parents fill out the PR application (while still in the country of asylum) or at the time that they fill out the OYW application (while in Canada)?

### **Our Answer**

A "dependent child" under <u>section R2</u>, is a child:

- under 22 years of age and not a spouse or common-law partner;
- 22 years of age or older, have depended substantially on the financial support of the parent since before the age of 22 and be unable to support themselves financially due to a physical or mental condition.

The age of dependent child is locked at the time the PSR application is received at Resettlement Operations Centre in Ottawa (ROC-O). If the dependent child is less than 22 years of age at the time of the application was received at ROC-O, then that child continues to be a dependent child even if they turn 22 years of age or older during the processing of the application, as long as they are still unmarried and not in a common-law relationship when **OYW** the application is submitted.

fully in-kind if shelter with adequate amount of rooms for the family members is provided without cost. Some allowances cannot be provided in-kind, for more information on these allowances, consult questions four and five on the <u>FAQs on Post-Arrival Financial Support</u>.

If a situation arises, where the adult children want to move and live independently, then it's important for the sponsoring group to have a contingency plan to support the separate households. If the sponsoring group is unable to support two separate households, then the sponsoring should contact IRCC for assistance in these situations.

#### UPDATED THE RESIDENCY REQUIREMENTS DOCUMENT

The updated residency requirements document contains clarification about what might happen if residency requirements are not met.

## Joint Assistance Sponsorship (JAS)

Refugees sponsored under the **Joint Assistance Sponsorship** (**JAS**) program have special or enhanced needs that will likely result in a longer or more difficult period of integration in Canada due to:

- Trauma from violence or torture;
- Medical disabilities:
- The effects of systemic discrimination; or,
- Being a large family unit (such as a single parent with several children).

Under the JAS program, the government and private sponsors support refugees for up to 24 months, depending on the needs of the resettled refugee. In a few cases, the private sponsor may support refugees for up to 36 months. These refugees receive income support from the Government of Canada. They are matched with a private sponsorship group to help them adjust to life in Canada with settlement help and emotional support.

Some refugees are identified overseas for the JAS program due to their special needs. Others are converted into JAS cases after they arrive in Canada if it becomes clear that they need more support.

The JAS program and a sponsor would be able to provide that extra time and support in order to help her successfully resettle within her community.

**Background:** A 50 year old man, who was accompanied to Canada by his wife (age 34) and their five children. Three of their children have intellectual disabilities that require various medical appointments and specialized schooling. The family speaks Tamasheq, a rare dialect that makes it difficult to find interpreters for.

**Support Needed:** A sponsor would help the family improve their life skills, and held them better navigate the health care system. Providing transportation, or helping the family to better navigate the public transportation system would ensure the children make it to their medical appointments.

**FAMILY SIZE: 3** 

**Background:** A single mother with two children (8 and 4) who came to Canada in June 2019. She is originally from Colombia but has been a refugee in Ecuador for a while. Upon arrival the following medical condition was identified "chronic condition of epilepsy."

**Support Needed:** A sponsor would be able to provide social and emotional support, help her in attending the various appointments be it medical, school related for herself or the kids, occasional shopping support, some mentoring on Life skills, support in the area of managing the life and education of her two kids. A JAS support would be beneficial for the whole family as she would have developed a network of people around her to support in the smooth integration to her settlement experience and the kids would be able to develop confidence needed for their overall growth and wellbeing.
