# Examples of Proof of Support Document from IRCC

IRCC has updated their examples of proof of support document, incorporating feedback from the Assurance Working Group.

The updated document is available in **English** and **French**.

The document provides examples of copies of documents that sponsors can submit to IRCC's <u>Resettlement Services Assurance Team (RSAT)</u> if they are requested to demonstrate during a case review that they provided financial and non-financial support to the newcomers in accordance with the relevant standards and policies.

During a case review, the onus is on the sponsors to submit copies of supporting documents to demonstrate that adequate support was provided, not the sponsored newcomers.

The list of examples in the document is not exhaustive and each case review will not require a copy of every document listed to be submitted to the RSAT.

### Letter Templates on the Canada Emergency Response Benefit (CERB) for Use by Sponsors

IRCC has shared letter templates that sponsors can adapt for use with the newcomers they sponsor so that the newcomers:

- Understand the consequences of applying and receiving funds from the Canada Emergency Response Benefit (CERB) if they do not meet the <u>eligibility</u> <u>requirements</u> of the program; and,
- Understand that any funds received from the CERB is considered to be earned income and that sponsors are able to reduce the level of monthly financial support

they provide if the funds the newcomer receives from the CERB reaches the 50% threshold for earned income.

### <u>ICYMI</u>: Updated Refugee Sponsorship Forms

IRCC is currently updating the privacy and personal information disclosures on all forms across the department.

As a result, there will be 2020 versions of **all refugee sponsorship/resettlement application forms**, including the forms for Sponsorship Agreement Holders (SAHs), Groups of Five and Community Sponsors.

The updates to the forms are being done in batches, so there will be 06-2020 and 07-2020 versions of various forms (the dates can be found in the bottom left hand corner of all the forms).

The changes to the forms do not impact processing at ROC-O and ROC-O will continue to accept previous versions of all forms as well as the new 2020 versions as they are posted on the IRCC website and the RSTP website.

If sponsors and refugees are working on a new refugee sponsorship application, they are encouraged to use the latest versions of the forms.

#### Did You Know?

At the end of 2019, there were 79.5 million forcibly displaced persons worldwide.

26 million are refugees, 45.7 million are internally displaced persons and 4.2 million are asylum seekers.

85% of the world's refugees are hosted in developing countries.

Resettlement/refugee sponsorship is a life saving durable solution and protection tool for refugees.

1.1 million refugees were resettled worldwide between 2010 and 2019 (70% of those refugees were referred for resettlement by the UNHCR).

700,000 refugees have been <u>resettled to Canada since 1959</u> under its four-refugee sponsorship/resettlement programs.

### How to Submit a **PSR Application to ROC-O Via Email**

If you are submitting a new PSR sponsorship application to ROC-O, you are strongly advised to do so via email so the application can be processed.

Please ensure that all new PSR applications are complete, and all the required forms and supporting documents are included with the application package, as currently there are no exemptions from the application requirements for new PSR applications being submitted to ROC-O.
