Applying for a Social Insurance Number

If a resettled refugee does not receive their Social Insurance Number (SIN) on arrival in Canada at the airport (i.e. the Port of Entry), they will need to apply for their SIN online.

When applying for a SIN, at least 3 different documents are required:

- 1. A valid <u>primary document</u> that proves the applicant's identity and legal status in Canada;
- 2. A valid <u>secondary document</u> to confirm the applicant's identity; and,
- 3. Proof of address.

IRCC has confirmed with Service Canada that:

- The Confirmation of Permanent Residence (COPR) document that is issued to permanent residents, including resettled refugees, qualifies as a valid primary document;
- A Single Journey Travel Document or a foreign passport can count as a valid secondary document; and,
- A letter from the Sponsorship Agreement Holder (SAH), Group of Five or Community Sponsor (if the applicant was resettled under the Private Sponsorship of Refugees (PSR) or the Blended Visa Office Referred (BVOR) programs) will be accepted as **proof of** address if:
 - The letter attests to the mailing address of the applicant; and,
 - The letter is signed by the sponsoring group and the applicant to confirm the mailing address.

The mailing address cannot be changed after submitting the application (unless a new application is submitted).

Therefore, if a temporary accommodation address was submitted as the mailing address, this is where the newcomer will receive their SIN (typically within 20 business days).
