ArriveCAN and Sponsored Refugees

As of [November 21, 2020](#), all persons entering Canada by air, including sponsored refugees, need to submit the following information via [ArriveCAN](#) before they board their flight:

- Their contact and travel information;
- Details of their quarantine plan; and,
- A COVID-19 symptom self-assessment.

After arrival in Canada, they must use [ArriveCAN](#) or call the 1-833-641-0343 toll-free line to:

- Confirm they have arrived at their place of quarantine within 48 hours of entering Canada; and,
- Complete a daily COVID-19 symptom self-assessment during their quarantine period.

IRCC is aware of the challenges sponsored refugees may have using [ArriveCAN](#) pre and post-arrival, including not having access to a mobile device or a computer and/or a internet or data connection, as well as the possibility of not having the language or digital literacy skills to provide the requested information.

IRCC is currently working with the Public Health Agency of Canada (PHAC) and their resettlement partners to identify solutions to these challenges.

Question

What option do sponsored refugees select for the “Document Type” field when providing their information via ArriveCAN?

Answer

The [Single Journey Travel Document](#) (SJTD) is currently being added to the list of selectable documents in ArriveCAN.

In the interim, sponsored refugees should select the “Passport” option for this field, their country of birth or nationality in the “Country of Issue” field and enter the number for the SJTD in the “Document Number” field (the number starts with the letter “T”).

Question

Can sponsors assist sponsored refugees with submitting their information pre-arrival?

Answer

Yes, where possible, sponsors can assist sponsored refugees with submitting their information via [ArriveCAN](#).

Question

Will sponsored refugees be denied boarding if they have not submitted their information via ArriveCAN?

Answer

No, sponsored refugees will still be permitted to board their flight if they are not able to submit the required information via [ArriveCAN](#) before boarding.

If the information is not submitted before boarding, the airline may provide the refugees with a paper form to complete or a paper form will need to be completed on arrival in Canada.
