You Asked

How much financial support are Groups of Five and Community Sponsors expected to provide to refugees sponsored under the Private Sponsorship Refugees (PSR) program?

Answer

When preparing an application, Groups of Five and Community Sponsors must use the <u>Sponsorship</u> <u>Cost Table</u> and the <u>In-Kind Deduction Table</u> to **estimate** how much money they need to provide to the refugees, along with the maximum amount for any deductions.

The amounts in the tables **are estimates only** and will be used by the Resettlement Operations Centre – Ottawa (ROC-O) when they assess the financial capacity of Groups of Five and Community Sponsors.

The amounts in the <u>Sponsorship Cost Table</u> are not the actual amount of money that the sponsors must provide to the refugees when they arrive in Canada.

The **actual** minimum level of financial support that sponsors must provide **on arrival** is based on the <u>Resettlement Assistance Program (RAP) rates</u>.

The RAP rates consist of two components: 1) <u>Start-Up Costs</u> and 2) <u>Monthly Income Support</u>. The Monthly Income Support component varies by province and the community of settlement.

The RSTP <u>Minimum Financial Support Calculator</u> can be used by Groups of Five and Community Sponsors to calculate the minimum level of financial support required on arrival based on the RAP rates.

You Asked

Is there anything Groups of Five and Community Sponsors need to consider when calculating the minimum level of financial support using the RAP rates?

Answer

When using the RAP rates, sponsors must consider the <u>age of majority</u> in the community of settlement.

Children that are over the age of majority on arrival (or who become so during the 12-month sponsorship period) must receive financial support as single adults.
