IRCC Update on Connecting Flights and Rail after Entering Canada

The new requirement to be fully vaccinated in order to travel domestically within Canada does not apply to resettled refugees and new permanent residents. New permanent residents and resettled refugees who don't qualify as fully vaccinated will be allowed to travel onward to their final destination in Canada in order to get established.

IRCC Update on the Omicron Covid-19 Variant of Concern

As a precautionary measure, until **January 31, 2022**, the Government of Canada is implementing enhanced border measures for all travellers who have been in **Botswana, Egypt, Eswatini, Lesotho, Malawi, Mozambique, Namibia, Nigeria, South Africa** and **Zimbabwe** within the last 14 days before arriving in Canada.

Foreign nationals who have travelled or transited any of these countries within the previous 14 days will not be permitted entry into Canada. This will impact the movement of sponsored refugees from those countries and has also resulted in movement cancellations where routing transited those countries. To the best extent possible, IRCC will continue to work with partners to facilitate the resettlement of refugees where conditions allow and where appropriate measures are in place to support them upon arrival. Any changes that impact travel that has already been booked will be shared with the affected sponsor, as updates become available.

How do we know that our Quarantine Plan was received? Is it possible for ROC-O to send an e-mail confirming the receipt?

Answer

In our conversation with ROC-O, they advised that their inbox is checked regularly. While they currently do not have a custom message to confirm the receipt of your Quarantine Plan (we forwarded your request, they are working on it), if you received an automatic reply thanking you for your e-mail, rest assured that your Quarantine Plan was received. That is currently the best mechanism to confirm the receipt of your plan.
