You Asked

The dependent child of a principal applicant (PA) was married after the sponsorship application was submitted. The application is still processing, what should we do?

Answer

If any dependent children on an application get married (or enter a common-law relationship) after the application is submitted, the applicant has a duty to report the marriage.

As a first step, we recommend that <u>you get in touch</u> with the overseas visa office responsible for the country the PA is in to inform them of this change in personal circumstance. It may be best to wait for the visa office's instructions before taking any next steps.

Children are only considered to be dependents if they are under the age of 22, not married and not in a common-law relationship. Once a child under the age of 22 is married, or is in a common-law relationship, they are no longer considered a dependent child (so long as the marriage is legal according to the laws of the place where it occurred; and complies with Canada's federal laws on marriage).

In such a case, the overseas visa office may ask them to submit a separate application or supplementary documents for the child who got married (or entered a common-law relationship) to be able to assess them separately.

*Please note, we strongly urge all applicants to disclose any change in personal circumstances after their application has been submitted.

Applicants have a duty to report changes, failure to do so could have negative implications impacting the new family member's reunification process.
