# Refugee Sponsorship Training Program

#### FREQUENTLY ASKED QUESTIONS

Q: sponsoring group wants to sponsor a minor 16-year-old Afghan refugee, living alone in Pakistan while his parents are back in their country of origin. Is there any way to sponsor the children alone?

A: There is currently a moratorium on sponsoring unaccompanied or separated minors for resettlement to Canada. There are two exceptions to the moratorium:

- 1. Unaccompanied/separated minors with a guardian over the age of 18 (where the minor is a de facto dependent of the guardian) and both the guardian and the de facto dependent minor are sponsored together on separate PSR application packages (the minor is considered to be a Principal Applicant in their own right in this scenario); and,
- 2. Unaccompanied/separated minors with family members in Canada that are willing to assume legal guardianship of the minor after arrival (the sponsors would submit a regular PSR application to ROC-O to start the process).

For both of the above exceptions, IRCC will conduct a best interest determination (BID) using UNHCR's BID guidelines to see if it is in the best interests of the child to be resettled to Canada and a cover letter included with the application explaining the child's situation may assist with this. If the child's parents' whereabouts are known, they will be expected to sign and submit the IMM 5604 form as an indication that the parent/s consent to their child travelling to Canada.

For the first exception, evidence of emotional and/or financial dependency between the minor and the de facto guardian (the test for de facto dependency) would need to be included with the application package. The evidence can be documentary (e.g. death certificates, guardianship/custody documents etc.), but a cover letter explaining the emotional and financial dependency should be included with both application packages.

For the second exception, the family member in Canada will be asked to sign an IMM 5590 form to acknowledge that they have obtained information on how to get legal guardianship in Canada and that they have the intention to do so after arrival. The family member should speak to a family lawyer about the procedure for obtaining legal guardianship as it varies from province to province.
