FREQUENTLY ASKED QUESTIONS



Q. Can resettled refugees travel outside of Canada before gaining citizenship?

The Canadian Counsel provides an elaborate answer to this question. People who arrive in Canada as refugees can travel outside Canada before they become Canadian citizens. However, they must be aware of certain conditions.

A. They need to have a Refugee Travel Document which can be used as a passport to travel to other countries (but not to the person's country of origin).

Refugees may need a visa to enter other countries. Some countries which allow Canadians to enter visa-free may require a visa for refugees. They may need to contact the consulate or embassy of the country where they would like to travel to check visa requirements.

Q. Can they travel to their country of origin?

A. Refugees traveling to their country of origin may lose their refugee status or their refugee status could be ceased.

Canada offers protection to refugees because they have shown that they are in danger in their home country. However, the Canadian government has the right to remove someone's refugee status if it believes that the person accepted the protection of their home country by returning to the country or obtaining a passport from that country (known as "reavailment")




