# Refugee Sponsorship Training Program

The latest news and updates on Canada's Refugee Sponsorship and Resettlement Programs

### WHAT IS THE IFHP? How does it relate to provincial healthcare coverage for newcomers who arrived under the Private Sponsorship of Refugees (PSR) or Blended Visa Office-Referred (BVOR) programs?

The Interim Federal Health Program (IFHP) provides limited, temporary coverage of healthcare benefits for specific groups of people in Canada, including sponsored refugees. It is administered by Medavie Blue Cross on behalf of IRCC.

In most provinces, newcomers who arrived as sponsored refugees are exempted from the threemonth wait period for provincial healthcare coverage. Please check the eligibility requirements with your provincial healthcare department.

While they wait to qualify for provincial healthcare or to receive their provincial health card, newcomers who arrived as sponsored refugees receive healthcare coverage via the IFHP.

### WHAT TYPE OF COVERAGE DOES IFHP **PROVIDE? HOW LONG DOES IT LAST?**

After the arrival of the sponsored refugees, IFHP provides two broad categories of coverage:

- 1. <u>Basic coverage</u> (until the newcomers are eligible for provincial coverage, to a maximum of 3 months after arrival), including: **Doctor visits**
- Hospital care
- Laboratory, diagnostic and ambulance services
- 2. <u>Supplemental coverage</u> (until the end of the sponsorship period—usually 12 months—even if the newcomer qualifies for provincial healthcare), including:
- Limited vision care
- **Urgent dental care** Mental health services
- Prescription medications

IFHP also covers the cost of the pre-departure Immigration Medical Exam (IME) for sponsored refugees.

#### IFHP? There is generally no need for sponsored refugees to

apply for IFHP. Sponsored refugees are usually provided with an IFHP Certificate of Eligibility by the Canada Border Services Agency (CBSA) upon arrival in Canada at the Port of Entry. Some refugees may also receive their certificate overseas, but where this is the case, they will receive another one on arrival in Canada. Note: It takes two business days from the day the certificate is issued for the eligibility information to be reflected in the Medavie Blue Cross system.

## Beneficiaries will not be reimbursed if they pay upfront

**HOW DO NEWCOMERS APPLY FOR** 

for a product or service covered by the IFHP. They must request services from a healthcare provider who is registered with Medavie Blue Cross and who will be able to receive reimbursement for services or products delivered under the IFHP. Beneficiaries must therefore first identify healthcare providers who are registered with Medavie Blue Cross before accessing a service or product. 
